The Wilson Society was established in 2004 to honor those who have included Wilson Memorial Hospital in their estate plans. The first member of the Wilson Society inducted was Harriet Scobey Stephenson who bequeathed \$10,000 to the Shelby County Memorial Hospital Association in 1918.

Donors who make a gift to Wilson through their estate planning are recognized as members of The Wilson Society. Their names are engraved on a special wall plaque located in the connecting corridor between the Outpatient Care Center and the Main Hospital.

New Wilson Society members are also inducted and honored annually at the Friends of Wilson reception each spring.
